An Order Establishing a Recovery Court for Navarro County

WHEREAS, the Commissioners' Court of Navarro County finds it in the best interest of the citizens of Navarro County that a Recovery Court be established as a Drug Court pursuant to Texas Government Code, Chapter 121; and

WHEREAS, Texas Government Code §123.002 provides that the Commissioners' Court of a county may establish a drug court program for persons arrested for, charged with, or convicted of:

- (a) an offense in which an element of the offense is the use or possession of alcohol, a controlled substance, a controlled substance analogue or marihuana; or
- (b) an offense in which the use of alcohol or a controlled substance is suspected to have significantly contributed to the commission of the offense and the did not involve:
 - (i) carrying, possessing, or using a firearm or other dangerous weapon;
 - (ii) the use of force against the person of another; or
 - (iii) the death of or serious bodily injury to another

NOW THEREFORE, BE IT RESOLVED that the Commissioners' Court Navarro County, Texas does authorize the establishment of the Navarro County Recovery Court program as a drug court to enable it to provide services needed by the citizens of our county.
